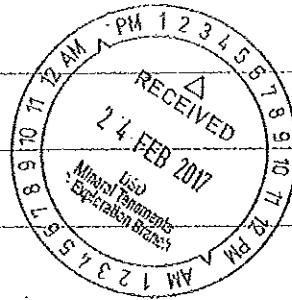

I applaud the Saving our Sustainability Group for encouraging landowners to fight for property rights.

The following is the text of a letter I felt compelled to send to a certain mineral exploration group.
