Please may I make
COMMENT ON THE MINING ACT 1971

In respect to the current ACT there are
areas that can be improved on.

1/ THE ACT NEEDS A SINGLE INDEPENDANT
NEUTRAL BODY THAT GRANTS MINING
APPROVAL WHEN ALL CONDITIONS HAVE BEEN
AGREED TO AND SIGNED OFF.

2/ THE ACT NEEDS A NEUTRAL ADMINISTRATOR
WHO CARRIES OUT COMPREHENSIVE
IMPLEMENTATION OF ALL REQUIREMENTS
AND REGULATIONS TO INSURE THEY HAVE
BEEN COMPLETED CORRECTLY.
THE ADMINISTRATOR NEEDS TO BE
PROPERLY RESOURCED.

3/ THE ACT NEEDS TO DEFINE CLEARLY
AND PRECISELY ALL THE REGULATIONS AND
CONDITIONS FOR ALL PARTIES INVOLVED.

4/ ALL REGULATIONS AND CONDITIONS OF
THE PROGRAMS FOR ENVIRONMENT
PROTECTION AND REHABILITATION BE
PUBLISHED AND MADE PUBLICLY AVAILABLE
TO ALL. SIX MONTHS PRIOR TO GRANTING
MINING APPROVAL.

MINING ACT REVIEW

5. ALL LAND IN USE FOR COMMERCIAL AND PRIVATE FOOD PRODUCTION SHOULD BE EXEMPT FROM MINING.

6. ANY MINING ACTIVITY THAT INTERFERES WITH OR CHANGES CURRENT GROUND OR SURFACE WATER QUALITY AND SUPPLY SHOULD STOP IMMEDIATELY.

7. ALL LAND OWNERS SHOULD HAVE UNRESTRICTED ACCESS TO PUT THEIR CONCERNS TO THE INDEPENDANT ADMINISTRATOR OF REGULATIONS, WITH THE RIGHT OF REPLY.

8. A SEPERATE INDEPENDANT NEUTRAL OMBUDSMAN SHOULD BE AVAILABLE TO HELP LAND OWNERS WHEN DISPUTES ARISE.

9. YOU MAY FEEL THE CURRENT ACT COVERS THESE AREAS. HOWEVER HISTROY HAS PROVEN THE WORKING BODIES INVOLVED ARE NOT NEUTRAL. NOR ARE THEY INDEPENDANT OF GOVERNMENT. THE REGULATIONS ARE NOT CLEARLY DEFINED, NOR ARE THEY PUBLIC. NOR ARE THEY ALWAYS CORRECTLY ENFORCED. DUE MAINLY TO A CONFLICT OF ECONOMIC INTREST.
